Resolution # 03-0813-247

Approval of Meeting Stipend for 5th and 6th Meeting in the Month of August for the Enrollment Commission

- WHEREAS, the U.S. Congress reaffirmed its recognition of the sovereign status of the Little River Band of Ottawa Indians (Tribe) as a federally-recognized Indian Tribe, pursuant to Public Law 103-324, 108 Stat. 2156 (25 U.S.C. §1300k et seq.); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998; and
- WHEREAS, the Tribal Council is authorized under the Constitution, Art. 4, sec. 7(a), to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council is authorized under the Constitution, Art. 4, sec. 7(f), to create regulatory commissions by Ordinance; and
- WHEREAS, the Tribal Council has adopted the <u>Commissions Ordinance</u>, November 2001, to set forth general directions and restrictions regarding the activities of Commissions of the Tribe; and
- WHEREAS, the <u>Commissions Ordinance</u> § 9.02(a) limits Commissioners to no more than 4 meetings per month; and
- WHEREAS, the <u>Commissions Ordinance</u> § 9.02 requires Tribal Council approval by Resolution to authorize payment of a stipend in excess of 4 per month; and
- WHEREAS, the Enrollment Commission has scheduled 6 meetings in the month of August, 2003, and is requesting Tribal Council authorization to receive a stipend for the 5th and 6th meetings scheduled to be held on 13 August 2003 and 25 August 2003; and
- NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves the payment of a 5th and 6th meeting stipend to the Enrollment Commission for the meetings of 13 August 2003 and 25 August 2003.
