## Resolution # 03-0813-255

Approval of Budget Modification Amending the Legal Department Budget, Program # 1000-109, and Transferring Funds to the Office of Ogema Budget, Program # 1000-102

- WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Anišhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council adopted the FY2003 Budget by resolution # 03-0226-55 in accordance with Article IV, Section 7(i)(1) of the Constitution; and
- WHEREAS, the Ogema, in accordance with Article V, Section 5(a)(6) and 5(c) of the Constitution, subsequently approved the FY2003 Budget on February 26, 2003; and
- WHEREAS, the FY2003 Budget has been amended from time to time by resolution of the Tribal Council and approval by the Ogema; and
- WHEREAS, the Ogema has presented a budget modification which transfers budgeted funds from the Legal Department to the Office of Ogema in recognition of separation of legal responsibilities to identify primary responsibilities of activities of the Office of Ogema and Tribal Council; and

WHEREAS, the Tribal Council has reviewed the budget modification and has determined that this action requires the Tribal Council and Ogema approval in accordance with the Constitution and section 5.10(d) of the <u>Budget and Appropriations Ordinance</u>, # 02-100-04;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves the budget modification set forth below moving funds from Program # 1000-109 to Program # 1000-102 to be placed in the same program lines and utilized for those same purposes outlined in the FY2003 Budget and Narratives.
