Approving Supplemental Appropriation for Anishinabemowin – Ottawa Language Preservation Program for FY2003 in the amount of \$41,016 from the General Fund

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, Stat. 2156 (25 U.S.C., 1300k et seq.)(hereinafter "Little River Act"); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power to provide for the general welfare of the Tribe and its members; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and
- WHEREAS, the Anishinabemowin Ottawa Language Preservation Program requires a supplemental appropriation in the amount of \$41,016 for costs associated with agreed upon match; and
- WHEREAS, the appropriation of funds from the General Fund will require a modification of the Operating Budget for Fiscal Year 2003, which was approved on February 26, 2003.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification to the Operating Budget for the Tribal Government for Fiscal Year 2003 to include an appropriation of \$41,016 from the General Fund – Gaming Proceeds Account. Funds shall be allocated as follows:

Program #4407-000 Anishinabemowin

Acct. # 5000 – Salaries \$ 30,609 # 5100/20/30 – Fringes <u>10,407</u> \$ 41,016
