Resolution # 03-0827-273

Authorizing Execution of Contract for Housing Repairs to Tribal Rental Housing Unit At 194 Quincy Street, Manistee, MI 49660

- WHEREAS, the status of the *Gaá Čhing Ziibi Daáwaa Anišhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council adopted the Budget and Appropriations Ordinance, #01-100-04, which identifies and authorizes expenditures of funds within an approved budget through regulations created by the Tribal Ogema and adopted by the Tribal Council; and
- WHEREAS, the Tribal Council has approved Purchasing and Procurement Regulations, #R100-01:AC-01 (as amended per Resolution #03-0625-189), which directs that authorization of expenditures in excess of \$5,000 must be made by the Tribal Council; and
- WHEREAS, the Housing Commission, by proper motion, has approved contracts in the amount of \$11,235.00, \$586.00 and \$2832.00 for repairs to the Tribal rental home at 194 Quincy Street;
- WHEREAS, the Housing Department has budgeted funds within Program #1116 (Rental Improvement Program), Account #5204 (Contract Services) for costs associated with the repairs to Tribal housing rental units; and
- WHEREAS, the Housing Department, through the Tribal Ogéma requests the Tribal Council to ratify the contract;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the Tribal Ogéma, or in the Ogéma's absence, the Tribal Giígidoó to execute contracts with Stephan Bernatche in the form presented as attached.
