Resolution # 03-1001-321

Approval of Budget Modification Amending the Members Assistance Department budget, Program #1000-137, and Transferring Funds to the Contract Health budget, Program #4103-000 in the amount of \$100,000

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, Stat. 2156 (25 U.S.C., 1300k et seq.)(hereinafter "Little River Act"); and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power to provide for the general welfare of the Tribe and its members; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and

WHEREAS, the Ogema has presented a budget modification which transfers budgeted funds from the Members Assistance Department to the Contract Health budget to support the need for additional funding for the continued provision of contract health services to the membership for the remainder of Fiscal Year 2003

WHEREAS, the Tribal Council has reviewed the budget modification and has determined that this action requires the Tribal Council and Ogema approval in accordance with the Constitution and section 5.10(d) of the Budget and Appropriation Ordinance, #02-100-04.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves the budget modification moving \$100,000 from Program #1000-137 – Members Assistance Department, Account #5208 and transferring those funds to Program #4103-000 – Contract Health, Account #5204 for expenses associated with the provision of contract health services to the membership.

Presentation of Resolution Budget Modification to Tribal Ogema:

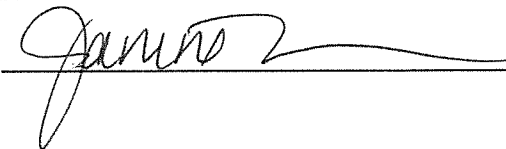
