## Resolution # 03-1015 352

Approval of Budget Modification Amending the Leadership Intern Program budget, Program #1000-108, and Transferring Funds to the Property Management budget, Program #1000-115 in the amount of \$1,500

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, Stat. 2156 (25 U.S.C., 1300k et seq.)(hereinafter "Little River Act"); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power to provide for the general welfare of the Tribe and its members; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and
- WHEREAS, the Ogema has presented a budget modification which transfers budgeted funds from the Leadership Intern Program budget to the Property Management budget to provide funding for the payment of electrical service to the Pow Wow Grounds; and
- WHEREAS, the Tribal Council has reviewed the budget modification and has determined that this action requires the Tribal Council and Ogema approval in accordance with the Constitution and section 5.10(d) of the <u>Budget and Appropriation Ordinance</u>, #02-100-04.
- NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves the budget modification moving \$1,500 from Program #1000-108 Leadership Intern Program, Account #5000 and transferring those funds to Program #1000-115 Property Management, Account #6002 for expenses associated with the payment of electrical service to the Pow Wow Grounds.
