Approval of a Budget Modification to the Great Lakes Fisheries Assessment Program to Allocate Space Costs

- WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Anišhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council has approved the budget for Fiscal Year 2003 by Resolution # 03-0226-55 which included the Great Lakes Fisheries Assessment Program; and
- WHEREAS, the Ogema, at the request of the Budget Manager and the Grants and Contracts Manager has identified that Space Costs in the amount of \$1772 should be allocated to the Great Lakes Fisheries Assessment Program, # 4018-000 which are funded by BIA Contract Funds previously accepted under resolution # 03-0827-269; and
- WHEREAS, the Tribal Council has reviewed this request and determined that it is an appropriate action;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves the Budget Modification to the Great Lakes Fisheries Assessment Program, #4018-000 to include \$1772 in line # 7005.
