Resolution # 03-1112-380

Approval of Expenditure for Maintenance - Dump Truck

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, Stat. 2156 (25 U.S.C., 1300k et seq.)(hereinafter "Little River Act"); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized, subject to the veto of the Tribal Ogema, under Article IV, Section 7(i)(1) of the Constitution to approve expenditures of Tribal funds; and
- WHEREAS, the Tribal Council adopted the Budget and Appropriations Ordinance, #01-100-04, which identifies and authorizes expenditures of funds within an approved budget through regulations created by the Tribal Ogema and adopted by the Tribal Council; and
- WHEREAS, the Purchasing and Procurement Regulations, #R100-01:AC-01 (as amended per Resolution #03-0625-189), have been approved by the Tribal Council which directs that authorization of expenditures in excess of \$5,000 must be made by the Tribal Council; and
- WHEREAS, the <u>Maintenance Department</u> has budgeted funds within Program #2000 -400, Account #5600 for costs associated with the purchase of a Dump Truck; and
- WHEREAS, the Tribal Council has received a request for approval of the above expenditure.
- NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves the expenditure of budgeted funds within Program #2000-400, Account #5600 in the amount of \$12,000 for the purchase of Dump Truck.
