Resolution # 03-1112-381

*Approval of Budget Modification Amending the Housing Administration
budget, Program #1000-124, and Transferring Funds to the Tribal Administration
budget, Program #2000-406 in the amount of \$63,340*

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, Stat. 2156 (25 U.S.C., 1300k et seq.)(hereinafter "Little River Act"); and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power to provide for the general welfare of the Tribe and its members; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and

WHEREAS, the Ogema has presented a budget modification which transfers budgeted funds from the Housing Administration budget to the Tribal Administration budget to provide funding for the payment of insurance premium; and

WHEREAS, the Tribal Council has reviewed the budget modification and has determined that this action requires the Tribal Council and Ogema approval in accordance with the Constitution and section 5.10(d) of the Budget and Appropriation Ordinance, #02-100-04.


NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves the budget modification moving \$63,340 from Program #1000-124 – Housing Administration as follows:

Acct. # 5201 – Background Investigations	\$ 5,000
# 5204 – Contract Services	30,000
# 5299 – Vehicles	15,000
# 5701 – Taxes	3,340
# 5802 – Travel	<u>10,000</u>
	\$63,340

IT IS FINALLY RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the transfer of these funds to Program #2000-406 – Tribal Administration, Account #5209 for expenses associated with the payment of insurance premium.


