# Approval of Expenditure for <u>Public Safety – Computers</u>

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, Stat. 2156 (25 U.S.C., 1300k et seq.)(hereinafter "Little River Act"); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized, subject to the veto of the Tribal Ogema, under Article IV, Section 7(i)(1) of the Constitution to approve expenditures of Tribal funds; and
- WHEREAS, the Tribal Council adopted the Budget and Appropriations Ordinance, #01-100-04, which identifies and authorizes expenditures of funds within an approved budget through regulations created by the Tribal Ogema and adopted by the Tribal Council; and
- WHEREAS, the Purchasing and Procurement Regulations, #R100-01:AC-01 (as amended per Resolution #03-0625-189), have been approved by the Tribal Council which directs that authorization of expenditures in excess of \$5,000 must be made by the Tribal Council; and
- WHEREAS, the <u>Public Safety Department</u> has budgeted funds within the COPS 2003 Tribal Resource Grant Program #4206-000, Account #5601 for costs associated with the purchase of eight (8) computers; and
- WHEREAS, the Tribal Council has received a request for approval of the above expenditure.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves the expenditure of budgeted funds within the COPS 2003 Tribal Resource Grant - Program #4206-000, Account #5601, in the amount of \$12,424 for the purchase of eight (8) computers.
