Resolution # 03-1203-399

*Approval of Budget Modification Amending the Accounting Department budget,
Program #2000-402, and Transferring Funds to the Tribal Ogema budget,
Program #1000-102 in the amount of \$56,000*

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, Stat. 2156 (25 U.S.C., 1300k et seq.)(hereinafter "Little River Act"); and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power to provide for the general welfare of the Tribe and its members; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and


WHEREAS, the Ogema has presented a budget modification which transfers budgeted funds from the Accounting Department budget to the Tribal Ogema budget to cover costs associated with various contractual obligations; and

WHEREAS, the Tribal Council has reviewed the budget modification and has determined that this action requires the Tribal Council and Ogema approval in accordance with the Constitution and section 5.10(d) of the Budget and Appropriation Ordinance, #02-100-04.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves the budget modification moving \$56,000 from Program #2000-402 – Accounting, Account #5000, and transferring those funds to Program #1000-102 – Tribal Ogema, Account #5204 for costs associated with various contractual obligations.
