Authorizing the Execution of a Change Order to the Contract with Davis Construction in the Amount of \$8,475.00 for Piping Associated with the Sludge Storage Tanks

- WHEREAS, the status of the *Gaá Čhíng Ziíbi Daáwaa Aníšhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, pursuant to Article IV, Section 5 (a)(4) and Article V, Section 5(a)(3) and (8) of the Tribal Constitution, the Tribal Ogema, or in his/her absence, the Tribal Council Speaker, is authorized to represent the Tribe in its relations with other organizations and manage the economic affairs/enterprises of the Tribe, in a manner consistent with the Tribal Constitution and resolutions of the Tribal Council; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (b) of the Constitution, has the power to authorize and ratify agreements and contracts negotiated by the Tribal Ogema; and
- WHEREAS, the Tribal Council did authorized execution of a construction contract with Davis Construction Inc., for the second phase of construction of the waste water treatment plant; and

- WHEREAS, the Construction Management Team did present a proposed Change Order to add the installation of sludge storage tanks the scope of work performed by Davis Construction, which excluded the cost of the piping associated wit that work; and
- WHEREAS, Davis Construction did present a Change Order request, which was not forwarded by the Construction Management Team, for completion of the required piping at a cost of \$8,475.00; and
- WHEREAS, the Finance Department is requesting approval of a Change Order for the completed work in order and the Tribal Council has determined that execution of a change order in the amount requested by the Finance Department is reasonable.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes execution of a Change Order to the Agreement for Construction Services (AIA form A101 and A201, as modified) with Davis Construction, Inc., to increase the amount of that contract by \$8,475.00 to cover the cost of the piping servicing the sludge storage tanks.
