Authorizing Execution of an Agreement with Northern Environmental Technologies, Inc. for Equipping and Installation of a Streamside Sturgeon Rearing Facility and Consenting to the Jurisdiction of the Commercial Division of the Tribal Court for Dispute Resolution

- WHEREAS, the status of the *Gaá Čhíng Ziíbi Daáwaa Aníšhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (b) of the Constitution, has the power to authorize and ratify agreements and contracts negotiated by the Tribal Ogema; and
- WHEREAS, the Tribal Council has been presented with a Professional Service Agreement and January 19, 2004 Proposal from Northern Environmental Technologies, Inc., for equipping a cargo trailer to serve as a Streamside Sturgeon Rearing Facility and installing/testing that Facility on Tribal property; and
- WHEREAS, the scope of work to be completed, as described in the proposed Agreement and January 19, 2004 Proposal will implement objectives defined in grant documents administered by the Tribe; and

WHEREAS, paragraph 20 of the Agreement provides that any disputes arising under the Agreement would be resolved in the Commercial Division of the Tribal Court; and

WHEREAS, the Tribal Council supports the Natural Resource Department's recommendation to utilize Northern Environmental Technologies, Inc. as a sole source vendor to complete the scope of services in accordance with the terms and conditions prescribed in the attached Professional Services Agreement and Proposal; and

WHEREAS, the Tribal Council believes that it is in the best interests fo the Tribe to consent to the jurisdiction of Tribal Court to permit enforcement of the Agreement with Northern Environmental Technologies, Inc.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the Tribal Ogema to execute the Professional Service Agreement with Northern Environmental Technologies, Inc. to retain that firm to provide the services defined in the firm's January 19, 2004 Proposal to fabricate and install the Streamside Sturgeon Rearing Facility on Tribally-owned lands within the Manistee Reservation.

IT IS FURTHER RESOLVED that the Tribal Council consents to the jurisdiction of the Commercial Division of the Tribal Court for purposes of resolving disputes that may arise under the agreement with Northern Environmental Technologies, Inc., in accordance with paragraph 20 of that Agreement.
