## Resolution #04-0218-70

Authorizing the Gaming Commission to Post and Hire a Compliance Manager

Pursuant to Resolution #03-0423-105

- WHEREAS, the status of the *Gad Ching Ziibi Dadwaa Anishinadbek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council is authorized to under Article IV, Section 7(i) to "take action, not inconsistent with this Constitution or Federal law, which shall be necessary and proper to carry out the sovereign powers of the Tribe; and
- WHEREAS, the Tribal Council did, pursuant to Resolution #03-0423-105, direct that the Tribal Ogema freeze all new hiring until such time as a human resource process review by the Tribal Council is completed; and
- WHEREAS, Resolution #03-0423-105 does authorize the Tribal Ogema to request Tribal Council authorization to hire new employment positions; and
- WHEREAS, the Tribal Gaming Commission has requested authorization to hire one (1) Compliance Manager to fill a vacant position authorized within the Gaming Commission's Program Budget which the Gaming Commission believes is necessary to permit the Commission to carry out its regulatory responsibilities;

WHEREAS, the Gaming Commission is making this request at the direction of the Tribal Ogema consistent with the terms of a Memorandum of Understanding between the Tribal Ogema and Gaming Commission regarding personnel matters; and

WHEREAS, the Tribal Council believes that the Gaming Commission's request for authorization to complete the recruitment process for the Compliance Manager position is in the best interests of the Tribe.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the Tribal Gaming Commission to proceed with recruitment process to fill one (1) vacant Compliance Manager Position within the Gaming Commission's Compliance Department.
