Resolution # 04-0218-71

Supplemental Appropriation to fund work to be completed by Corporate Computer in the amount of \$32,754

WHEREAS, the status of the *Gaá Čhing Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and

WHEREAS, the Tribal Council engaged in a contract with Corporate Computer, Inc., by Resolution # 04-0114-18, and amended by Resolution # 04-0204-48, which authorized digital copying of records in the Enrollment Department.; and

WHEREAS, the Tribal Council will require a supplemental appropriation to provide the funds needed to meet the obligations to be authorized under the Corporate Computer, Inc. contract; and

WHEREAS, the Tribal Council agrees that it is in the Tribe's best interest to appropriate the funds needed to permit Corporate Computer, Inc. to complete the digital copying of records.

WHEREAS, the appropriation of funds from the General Fund will require a modification of the Operating Budget for Fiscal Year 2004, which was approved on December 17, 2003.


NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification to the Operating Budget for the Tribal Government for Fiscal Year 2004 to include a supplemental appropriation of \$32,754 from the General Fund - Gaming Proceeds Account. Funds shall be allocated as follows:
