Acceptance of FY2004 Indian Health Service (IHS) P.L. 93-638 Contract Funds and Approving a modification to the Operating Budget for Fiscal Year 2004 in the amount of \$1,197,694

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, Stat. 2156 (25 U.S.C., 1300k et seq.)(hereinafter "Little River Act"); and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power to provide for the general welfare of the Tribe and its members; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and


WHEREAS, the acceptance of contract funds from Indian Health Service (IHS) will require a modification of the Operating Budget for Fiscal Year 2004, which was approved on December 17, 2003.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification to the Operating Budget for the Tribal Government for Fiscal Year 2004 to include contract funds in the amount of \$1,197,694 from Indian Health Service. Funds shall be allocated as follows:


Program # 4103-000 Contract Health (Direct Cost):	\$ 508,350
Program # 4103-000 Contract Health (Indirect Cost):	137,564
Program # 4104 – 000 Clinic Operations (Direct Cost):	523,870
Program # 4105 – 000 Behavioral Health (Direct Cost):	<u>27,910</u>
