Iisa mccatty stated that she Would like the Legislative Committee to work on drafting a proposal. DISCUSSION AMONGST THE COUNCIL AND OTHERS PRESENT TOOK PLACE IN REGARDS TO A GERMAN SHEPARD WHICH HAD BEEN PURCHASED THROUGH THE POLICE DEPARTMENT, AND A RECENT LETTER WHICH HAD BEEN RECEIVED FROM THE TRAINER OF THE DOG REQUESTING A HANDLER BE NAMED TO WORK WITH THE ANIMAL. IT WAS MENTIONED THAT ALTHOUGH THE MATTER OF THE POLICE DOG WAS CONCERNING, THE AGENDA ITEM WAS ACTUALLY ASKING FOR A POLICY OR LAW TO be DRAFTED FOR ANY ANIMAL OWNED BY THE TRIBE NOW, OR IN THE FUTURE.
