Approval for Requested Use of FY2003 Unexpended Funds

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, Stat. 2156 (25 U.S.C., 1300k et seq.)(hereinafter "Little River Act"); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power to provide for the general welfare of the Tribe and its members; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and
- WHEREAS, Section 5.10(f) of the Budget and Appropriations Ordinance authorizes the utilization of available unexpended funds to cover outstanding invoices which were authorized in the preceding fiscal year; and
- WHEREAS, the Tribal Ogema has presented a request for use of available unexpended funds from Fiscal Year 2003 for application to outstanding invoices, which were properly authorized in FY2003; and
- WHEREAS, the Tribal Ogema has identified the following invoices as being properly authorized in FY2003, and of which outstanding invoices exist in FY2004.
