Approval of Supplemental Appropriation for Purchase of Copier for Tribal Council Office

WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and


WHEREAS, the Tribal Council has identified that a supplemental appropriation is needed to cover costs associated with the purchase of a copier for the Tribal Council office; and

WHEREAS, the Chief Financial Officer has identified that sufficient funds exist to allow this supplemental appropriation to be made and the appropriate documentation has been forwarded identifying these funds; and


NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approve a supplemental appropriation in the amount of \$18,287.00 to be placed in Program # 1000-100, Tribal Activities line # 5601.
