

Approval of Modification of the Organization Chart to Include Finance Department and the Related Employment Positions

- WHEREAS, the status of the Gaá Čhíng Ziibi Daáwaa Anišhinaábek (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council accepted the Standard Operating Procedure of the Human Resource Department as approved by the Ogema regarding the 'Organizational Structure Policy' by resolution # 04-0303-98; and
- WHEREAS, the Tribal Council approved the current organizational structure of the Tribal government by adoption of resolution # 04-0303-99; and
- WHEREAS, the Organizational Structure Policy requires the recommendation of the Ogema to amend the organizational structure to be approved by resolution by the Tribal Council prior to authorization to make any change; and
- WHEREAS, the Ogema has presented a recommendation to amend the organizational structure by inclusion of the Finance Department with the director reporting to the Tribal Manager; and
- WHEREAS, the Tribal Council has reviewed this request and has determined that it is an appropriate action to take;
