Ratification of Contract with Netcom for the Purpose of Funding the Purchase of a Phone System for Off Site Properties

- WHEREAS, the status of the Gaá Čhíng Ziíbi Daáwaa Aníšhinaábek (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Information Services Department has identified a need to include offsite offices of the Tribe in the Tribe's integrated phone systems in order to better manage messaging, phone transfer, and other related activities; and
- WHEREAS, a contract with Netcom has been presented which will provide equipment, software licensing and installation which has been reviewed and approved by the Ogema; and
- WHEREAS, the Ogema has forwarded the above contract to the Tribal Council for review and approval; and

WHEREAS, the Information Services Department has requested supplemental appropriations for this activity which was approved by resolution # 04-0721-305; and

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby ratifies the contract with Netcom in the amount of \$97,741.74 and authorizes the Ogema to execute that contract.
