**Resolution # 04-0821-339**

*Approval of Expenditure by Tribal Council for Little River Casino Resort for Re-Affirmation Day Feast on September 18, 2004 in the amount of \$4,275.00*

WHEREAS, the status of the *Gaá Čhing Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Tribal Council is authorized, subject to the veto of the Tribal Ogema, under the Article IV, Section 7(i)(1) of the Constitution to approve expenditures of Tribal funds; and

WHEREAS, the Tribal Council adopted the Budget and Appropriations Ordinance, # 01-100-04, which identifies and authorizes expenditures of funds within an approved budget through regulations created by the Tribal Ogema and adopted by the Tribal Council; and

WHEREAS, *Chapter 5. Purchasing and Procurement Tribal Council*, # R100-01:AC-05, been approved by the Tribal Council which directs that authorization of expenditures in excess of \$2,500.01 must be made by the Tribal Council; and


WHEREAS, the Tribal Council has remaining budgeted funds in the amount of \$7,000.00, which can be obligated for the purpose of providing a meal related to the 2004 Re-Affirmation Day Feast; and

WHEREAS, the Tribal Council has received a request for approval of the above expenditure;


NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves the expenditure of budgeted funds in the amount of \$4,275.00 to provide a meal for the 2004 Re-Affirmation Day Feast by the Little River Casino Resort.
