

LITTLE RIVER BAND OF OTTAWA INDIANS TRIBAL COUNCIL MEETING APRIL 9, 1995

I. GENERAL BUSINESS

- a. Call to Order. Meeting was called to order by Bonnie Kenny, at 12:10 noon at the office.
- b. Roll Call. Tribal Council members present: Margaret Chandler, Marcella Leusby, Kathy Berentsen, Anne Avery, Bonnie Kenny.
 Absent: Dan Bailey and Mark Dougher. Staff Present: Diane Lonn. Guest present: John Koon, Jerry Guenthardt, Dave Schultz, Herb Barton (free agent police department/conservation), Tim News Advocate, Kurt Schindler, Dale Chandler, and Bill Willis.
- c. Add Tribal Seal to Adoption of Agenda. Anne motioned to accept agenda, Margaret seconded, all in favor, I. passed..
- d. Minutes. Kathy will take care of minutes on computer from March/April. Anyone who comes into volunteer can do that.
- e. Financial Report. Bonnie read letter addressing Ada Deer so members could understand. Mark received response from Ann Botton in fax form. Bonnie recommended Bob and Economic Development to be involved with Denise and Anne. Total budget 10,733.38 loan given 15,000. Bonnie and Mark approved what checks are cut due to no money. Left 7,200. Anne traveled in Jan/Feb never received money. Kathy made motion to pay Anne, Marcella seconded, all in favor, I. Passed. 500 sent to us for fravel 4/17-20.
