Approval of Amended Job Classification System Salary Levels and Scales for the Little River Casino Resort

- WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Anišhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council and Manistee Gaming, LLC (Manager) have entered into a management contact for the purposes of operating the Little River Casino Resort; and
- WHEREAS, the Second Amended and Restated Management Agreement (Management Agreement) identifies the responsibilities and limitations of the Tribe and the Manager; and
- WHEREAS, the Little River Casino Resort shall"...establish a job classification system with salary levels and scales which shall be submitted to the Board and the Tribal Council for approval, "Management Agreement, section 4.6.2; and

- WHEREAS, the Tribal Council has approved the salary levels and scales by resolution #01-0919-08 which have been amended once by resolution #01-0919-08, and has been affected by Cost of Living Increases as well as individual personnel affected by merit increases since its adoption; and
- WHEREAS, the General Manager has approved a proposed amendment to the salary levels and scales addressing changes in the federal guidelines regarding overtime and exempt employees which requires a change on Job Grade A; and
- WHEREAS, the Business Board has reviewed and approved this on July 27, 2004 and directed the proposal to be forwarded to the Tribal Council for approval in accordance with the Management Agreement;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves the Little River Casino Resort's Salary Structure and, repeals the prior version approved by Resolution # 01-0919-08.
