Resolution # 04-1103-441

Approval of Budget Modification to the Housing Department of \$78,000 from line items 5000, 5205, 5301, 5305 and 5603 to 6100

WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Ogema has presented a budget modification which transfers budgeted funds from Housing Department Line Items 5000, 5205, 5301, 5305 and 5603 to Capital Outlay Line Item 6100 for the purchase of streetlights at Aki' maadiziwin; and

WHEREAS, the Tribal Council has reviewed the budget modification and has determined that this action requires the Tribal Council and Ogema approval in accordance with the Constitution and section 5.10(d) of the Budget and Appropriation Ordinance, #02-100-04.


NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves the budget modification moving \$50,000, \$10,000, \$9,000, \$3000, and \$6,000 from Housing Department Budget Line Items 5000 (Salaries and Wages), 5205 (Professional Fees), 5301 (Repair & Maintenance), 5305

(Advertising) and 5603 (Office Supplies) respectively, to Line Item #6100 Capital Outlay.


IT IS FINALLY RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the transfer of these funds from Housing Department Budget Line Items 5000 (Salaries and Wages), 5205 (Professional Fees), 5301 (Repair & Maintenance), 5305 (Advertising) and 5603 (Office Supplies) respectively, to Line Item #6100 Capital Outlay for the purchase of streetlights for Aki' maadiziwin.
