## **Resolution # 04-1201-478**

Overriding the Veto of Resolution #04-1120-471 - Budget Modification Regarding Funding for Tribal Manager Position

- WHEREAS, the status of the Gaá Čhíng Ziíbi Daáwaa Aníšhinaábek (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council has reviewed the operations of the Tribal government and the Ogema's responsibilities under the Constitution, and by adoption of resolution #04-1120-471 determined that the position of Tribal Manager was a duplication of the responsibilities of the Ogema that the Ogema should be conducting; and
- WHEREAS, the Tribal Council adopted resolution #04-1120-471 which amended the operating budget for Fiscal Year 2004 by removing funding for the duplication position of Tribal Manager as authorized by Article IV, Section 7(i)(1) of the Constitution which may be subject to the veto of the Ogema; and

WHEREAS, the Tribal Council has received the veto of the Ogema regarding resolution #04-1120-471 and has determined, as authorized by Article V, Section 5(c), by adoption of this resolution by at least 6 of the 9 Tribal Councilors to override the Ogema's veto as an action in the best interests of the Tribe;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby overrides the Ogema's veto of resolution # 04-1120-471, Amending the Budget to Remove Funding for the Position of Tribal Manager and to Move Funds to the General Fund of the Tribe, and directs the Ogema to sign the document, resolution #04-1120-471, notwithstanding his objections and implement the resolution immediately.
