Resolution # 04-1201-483

Supplemental Appropriations to Fund Christmas Food Voucher Program

- WHEREAS, the status of the Gaá Čhíng Ziibi Daáwaa Anišhinaábek (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council is delegated responsibility under Article IV, Section 7(i)(2) to manage the funds of the Tribe and appropriate such funds for the benefit of Tribal members; and
- WHEREAS, the Tribal Council has determined to adopt a Christmas Food Voucher Program to assist Tribal member families during this season of family gatherings; and
- WHEREAS, the Tribal Council requires a supplemental appropriation for the purposes of funding this necessary activity; and
- WHEREAS, the Chief Financial Officer has provided a Certification of Availability of Funding in the necessary amount;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the appropriation of \$215,000.00 from the General Fund Unrestricted Revenues for allocation to the Members Assistance Program budget line 1000-137, Program #5202 for the purposes of funding the Christmas Food Voucher program.
