Resolution # 04-1215-519

*Approval of Budget Modification Amending the Elders Assistance budget,
Program #1000-105, and Transferring Funds to the Bereavement budget,
Program #1000-123 in the amount of \$30,000*

WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Tribal Ogema has presented a budget modification which transfers budgeted funds from the Elders Assistance budget to the Bereavement budget to cover unanticipated bereavement benefits to eligible tribal member families; and

WHEREAS, the Tribal Council has reviewed the budget modification and has determined that this action requires Tribal Council and Ogema approval in accordance with the Constitution and section 6.03(a) of the Budget and Appropriations Ordinance #02-100-04 (as amended).

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves the budget modification moving \$30,000 as follows:



IT IS FURTHER RESOLVED THAT the Tribal Council authorizes these funds to be transferred as follows:


Bereavement - Program #1000-123, Acct. #5208 \$30,000
