**Approval of the Audit Service Engagement Letter from Rehmann Robson for the
FY 2025 Audit**

WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribe adopted amendments to the Constitution on July 11, 2016 which became effective upon approval by the Assistant Secretary-Indian Affairs on August 24, 2016; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Tribal Council is vested with the authority, under Article IV, Section 7(b), to ratify contracts to be entered into by the Tribe; and

WHEREAS, the Tribal Council has received a contract with Rehmann Robson to conduct the 2025 Financial Audit; and

WHEREAS, the Rehmann Robson firm will bill in three installments for progress in audit work, and at the end for the implementation of the mandatory GASB 101; and

WHEREAS, if the audit company is required to audit more than two (2) major programs, those additional costs will be billed to the Tribe; and

WHEREAS, the contract has been reviewed by Executive Legal ; and

WHEREAS, the terms of the engagement shall be construed under the laws of the State of Michigan and any dispute or controversy arising out of or relating to this engagement of contract shall be submitted to arbitration;

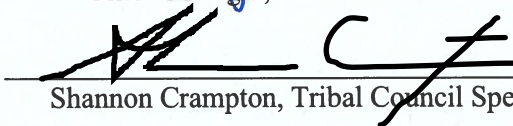
NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the Tribal Ogema and other Executive and Legislative personnel to execute the Agreement with Rehmann Robson incorporating the contents of this resolution.
