Resolution # 05-0216-66

*Approving Supplemental Appropriation in the amount of \$10,000 for Line Item #5310
Property Repair/Maintenance not included as part of the approved FY2005 Housing
Department Operating Budget*

WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Tribal Ogema is requesting a supplemental appropriation be made to Housing Department Budget Item #5310 Property Repair/Maintenance to fund repairs authorized under 2004 budget but not appropriated before the expiration of the 2004 budget authority, and thus was not included as part of the approved FY2005 Operating Budget; and


WHEREAS, the appropriation of funds from the General Fund will require a modification of the Operating Budget for Fiscal Year 2005, which was approved on December 15, 2004.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification to the Operating Budget for the Tribal Government for Fiscal Year 2005 to include an appropriation of \$10,000 from the General Fund – Gaming Proceeds Account for funding of line item #5310 Property Repair/Maintenance in the Housing Department's 2005 budget..

Presentation of Resolution Budget Modification to Tribal Ogema:


