## **Resolution # 05-0309-102**

Emergency Amendments to the <u>Enrollment Ordinance</u> for the Purpose of Allowing Access to Database Information by the Election Board for Purposes of Generating Ballots and other Related General Election Documents

- WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Anišhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council is authorized under Article II, Section 4, to establish, by ordinance, processes related to enrollment, which include those activities by which the membership roll of the Tribe, and related information, are maintained; and
- WHEREAS, the Constitution creates the Election Board and delegates to that body the responsibility to manage the elections of the Tribe, which requires access to information located, and maintained, by the Enrollment Department; and

- WHEREAS, the Tribal Council has adopted the <u>Enrollment Ordinance</u> which requires that the records and information in the Enrollment Department related to membership be maintained in a confidential manner, with limited authorization for the release of information; and
- WHEREAS, the Enrollment Ordinance does not adequately identify authorization for the Enrollment Department to release information to the Election Board, in electronic format, nor to allow access to electronic records, for the purposes of developing election related materials; and
- WHEREAS, the Tribal Council adopted the <u>Administrative Procedures Act Ordinances</u> which identifies processes by which ordinances may be adopted, amended, or repealed, and which also identifies processes by which emergency amendments may be authorized;
- WHEREAS, the Election Board has identified that it is unable to obtain the necessary information from the Enrollment Department in order to produce ballots and mailing lists as a result of the limited authority currently granted to the Enrollment Department to release information; and
- WHEREAS, there is insufficient time to develop and post amendments for public comment as a result of the upcoming elections and the need to have the electronic information obtained by the election ballot company selected by the Election Board in order to print and mail ballots; and
- WHEREAS, this requires action by the Tribal Council authorize emergency amendments to the Enrollment Ordinance which allows access by the Election Board, or their approved vendor, to access the enrollment database in a secured and confidential manner, to obtain electronic information for the purposes of conducting the 2005 General Election:
- NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby adopts, under authority of Article V of the <u>Administrative Procedures Act Ordinances</u>, the following emergency amendment to the <u>Enrollment Ordinance</u> which shall be effective until the last day of May, 2005.
  - 11.03(a)(6). The Election Board, or the contracted vendor authorized to develop ballots and related mailing and election related materials, is authorized to obtain, directly from the Enrollment Department electronic files, necessary information to conduct the 2005 General Election. Provided that, the Election Board, and/or contracted vendor, shall identify, to the Enrollment Department, the information obtained, and shall agree that upon conclusion of the 2005 General Election, that all electronic information shall be destroyed and not maintained by either the Election Board or their contracted vendor.
