## **Resolution # 05-0420-158**

Approving Supplemental Appropriation for completion of the Little River Band of Ottawa Indians 2003Financial Statement Audit in the amount of \$30,000.00

- WHEREAS, the status of the *Gaá Čhíng Ziíbi Daáwaa Aníšhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribe has caused to have a financial statement audit to be conducted for the year ending December 31, 2003; and
- WHEREAS, the Accounting Firm of Ribail, Stauffer and Associates, PLLC have indicated that additional costs from the original contract have been incurred; and
- WHEREAS, the appropriation of funds from the General Fund will require a modification of the Operating Budget for Fiscal Year 2005, which was approved on December 15, 2004.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification to the Operating Budget for the Tribal Government for Fiscal Year 2005 to include an appropriation of \$30,000.00 from the General Fund — Gaming Proceeds Account for costs associated with the completion of the Little River Band of Ottawa Indians 2003 financial statement audit. Funds shall be allocated as follows:

Program #1000-100 Tribal Council, Acct. #5205 – Professional Fees \$ 30,000.00
