Resolution # 05-0608-236

*Acceptance of Donated Funds and Approving a modification
To the Operating Budget for fiscal year 2005 in the amount of \$275.00*

WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, Stat. 2156 (25 U.S.C., 1300k et seq.)(hereinafter "Little River Act"); and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power to provide for the general welfare of the Tribe and its members; and

WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and

WHEREAS, the acceptance of donated funds will require a modification of the Operating Budget for fiscal year 2005, which was approved on December 15, 2004.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification to the Operating Budget for the Tribal Government for fiscal year 2005 to include donated funds in the amount of \$275.00 from the following entity:

Michigan Indian Elders Association / \$ 275.00

IT IS FURTHER RESOLVED THAT these funds shall be allocated and maintained in the Donations Program # 1000-145.

CERTIFICATE OF ADOPTION

Presentation of Resolution Budget Modification to Tribal Ogema:

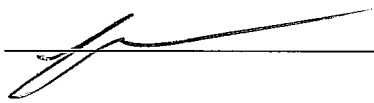
