Resolution 05-0713-310

Authorization to Post and Hire Receptionist Job Position within the Health Services Department

WHEREAS, the status of the Gaá Čhing Ziibi Daáwaa Anišhnaábek (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Tribal Ogema has identified that the position of Receptionist within the Health Services Department is needed as the position will allow for centralized access to services for members. This position will service clinic, behavioral, CHS and EHAP programs; and

WHEREAS, the Tribal Ogema has identified that it is necessary to post and fill this position with a qualified individual in order to provide reception services of the Health Services Department to the Tribal membership; and

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the posting of Receptionist job position and hiring an individual to fill that position in accordance with the Tribe's hiring processes.

CERTIFICATE OF ADOPTION

I do hereby certify that the foregoing resolution was duly presented and adopted by the Tribal Council with 4 FOR, 2 AGAINST, 1 ABSTAINING, 1 ABSENT, and 1 VACANT, at a Regular Session of the Little River Band of Ottawa Indians Tribal Council held on July 13, 2005, at the Little River Band's Dome Room in Manistee, Michigan, with a quorum being present for such vote.
