Authorization to Utilize Gathering Grounds for the Purposes of Camping by the Shoreline Bicycle Tour Group on July 31, 2005

- WHEREAS, the status of the *Gaá Čhíng Ziíbi Daáwaa Anišhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council adopted the <u>Interim Land Use Restrictions</u> by resolution # 00-1212-08, which closed or restricted Tribal properties to Tribal member use; and
- WHEREAS, the Gathering Grounds has been designated as a semi-open area of the purpose of public gatherings; and
- WHEREAS, the Tribal Council has been presented with a request by the Ogema to have the Gathering Grounds opened to the Shoreline Bicycle Tour on July 31, 2005 for the purposes of providing a camping area and the opportunity to educate the general public regarding the Tribe; and

WHEREAS, the Tribal Council finds that this purpose meets the needs of furthering the Tribal goal of educating the general public about the Tribe and its history such that opening the Gathering Grounds for the purpose of this activity is appropriate;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the use of the Gathering Grounds for camping by the Shoreline Bicycle Tour on the night of July 31, 2005.
