Approval of Supplemental Appropriation by Tribal Council for additional meetings for the Enrollment Commission in the amount of \$15,400.00

- WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Anišhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council is authorized, subject to the veto of the Tribal Ogema, under the Article IV, Section 7(i)(1) of the Constitution to approve expenditures of Tribal funds; and
- WHEREAS, the Tribal Council adopted the Budget and Appropriations Ordinance, # 01-100-04, which identifies and authorizes expenditures of funds within an approved budget through regulations created by the Tribal Ogema and adopted by the Tribal Council; and
- WHEREAS, the *Purchasing and Procurement Regulations*, # R100-01:AC-01, Chapter 5, have been approved by the Tribal Council which states expenditures over \$2,500 need to be approved by Tribal Council Resolution; and

- WHEREAS, the Tribal Council has received a request from the Enrollment Commission for additional file review meetings for the months of August, September, October, November and December 2005 which will require additional stipends of \$15,400; and
- WHEREAS, the Tribal Council has requested a supplemental appropriation to the Tribal Council Program (#1000-100) for costs associated with the additional file review meetings for the Enrollment Commission; and
- WHEREAS, the Tribal Council has received a request for approval of the above expenditure

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council approves a supplemental appropriation from the General Unrestricted Revenues account in the amount of \$15,400 to Program 1000-100-5206, subaccount #526 for adding additional file review meetings for the Enrollment Commission.
