Approving Budget Modification for <u>Education Department</u>, <u>Program #4026-000</u> in the amount of \$3,750

- WHEREAS, the status of the *Gaá Čhíng Ziíbi Daáwaa Aníšhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council amended the Budget and Appropriations Ordinance, #01-100-04, through the passage of Resolution #04-1006-396, which establishes authorization levels for the approval of line item budget modifications; and
- WHEREAS, Section 6.03(b) of the Budget and Appropriations Ordinance as amended, authorizes the Tribal Ogema to approve the reallocation of funding appropriated to a department, provided that the combined amount of individual modifications to a single program budget may not exceed 10% of the original program budget; and

WHEREAS, the Tribal Council is requesting a budget modification be taken from the Tribal Council Budget Program 1000-100, line item 5802 (travel) in the amount of \$3,750 to be used for the Education Department, Program #4026-000, line item 5203 (client services, subaccount 285 (student services); and

WHEREAS, the Tribal Council believes the driver's education program is important for the youth of the Tribe; and

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians in accordance with the Budget and Appropriations Ordinance, (as amended), hereby approves a budget modification from the Tribal Council Budget Program #1000-100, 5802 in the amount of \$3,750 to be used for the Education Department, Program #4026-000, 5203, subaccount 285. The allocation shall be as follows:

Tribal Council – Program #1000-100

Decrease Acct. # 5802 – Travel

Education Department – Program #4026-000

Increase Acct. # 5203 – Client Services

Subaccount 285 – Student Services
