### Resolution # 05-0914-451

#### *Approval of Expenditure for Family and Community Wellness Conference at Little River Casino Resort*

WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Tribal Council is authorized, subject to the veto of the Tribal Ogema, under the Article IV, Section 7(i)(1) of the Constitution to approve expenditures of Tribal funds; and

WHEREAS, the Tribal Council adopted the Budget and Appropriations Ordinance #, which identifies and authorizes expenditures of funds within an approved budget through regulations created by the Tribal Council; and

WHEREAS, the *Purchasing and Procurement Regulations*, # R100-01:AC-Chapter 1, have been approved by the Tribal Council which directs that authorization of expenditures in excess of \$8,000.00 must be made by the Tribal Council; and


WHEREAS, the Historic Preservation Office has budgeted \$53,800 for the purpose of entering into program related activities to hold the Family Wellness Conference beginning September 14, 2005 and ending on September 16, 2005 at the Little River Casino Resort; and

WHEREAS, the Tribal Ogema is requesting approval of the above expenditure;


NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves the expenditure of budgeted funds in the amount not to exceed \$8,113.00. These funds are budgeted under Program 1000-154-100-5202.
