Approving an amendment to the Operating Budget for the Tribal Government for Fiscal Year 2005 to include a transfer of \$22,252 from the General Obligations Fund to the Food Distribution Program on Indian Reservations

- WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Anišhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and
- WHEREAS, the USDA Food Distribution Program on Indian Reservations requires a cash match contribution in the amount of \$22,252 to support the Program's operational expenses between 10/01/05 12/31/05; and
- WHEREAS, the transfer of funds from the General Obligations Fund to the Food Distribution Program on Indian Reservations will require an amendment to the Operating Budget for FY 2005, which was approved on December 15, 2004.

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves an amendment to the Operating Budget for the Tribal Government for Fiscal Year 2005 to include a transfer of \$22,252 from the General Obligations Fund to the Food Distribution Program on Indian Reservations. Funds shall be allocated as follows:

From: General Obligations Fund

Program # 1000-156-6120

Amount: \$22,252

To: Food Distribution Program on

Indian Reservations Program # 4265-000

IT IS FURTHER RESOLVED THAT the Tribal allocation cited above will be used effective October 1, 2005 to fund the entire operational expenses of the Food Commodity Program until such time as the USDA Program grant is awarded and accepted into the Tribal Budget. The Tribal Budget Manager is to ensure that the USDA Program grant will be used to reimburse Tribal funds for the federal share of those costs incurred in the interim.
