### Resolution # 05-1005-490

*Approving Budget Modification for Gaming Commission,  
Program #1000-121 in the amount of \$60,000.00*

WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Tribal Council amended the Budget and Appropriations Ordinance, #01-100-04, through the passage of Resolution #05-0817-391, which eliminates the Tribal Ogema's authority to approve line item budget modifications under Section 6.03; and

WHEREAS, the Gaming Commission department, Program #1000-121 has requested a line item budget modification in the amount of \$60,000.00, to cover background investigation expenses due to vendor licensing fee's not being deposited into the professional fee's line item as anticipated.


NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians in accordance with the Budget and Appropriations Ordinance, (as amended), hereby approves a line item budget modification for the Gaming Commission Department, Program #1000-121 in the amount of \$60,000.00. Funding shall be allocated as follows:


Program #1000-120 – Surveillance	
Decrease Acct. # 5000 – Salaries	(60,000)
Program #1000-121 – Gaming Commission	
Increase Acct. # 5205 – Professional Fees	60,000

IT IS FURTHER RESOLVED that an encumbrance be established for IntelQuest, Ltd. in the amount of \$60,000.00 out of Account #1000-121, line item #5205 to cover background investigation expenses for the remainder of the year.

Presentation of Resolution Budget Modification to Tribal Ogema:


