## **Resolution # 05-1005-496**

Approving 4<sup>th</sup> Quarter Funding Appropriation of FY2005 Operating Budget

- WHEREAS, the Tribe's status as a federally-recognized Indian tribe was reaffirmed and restored by Congress pursuant to Public Law 103-324, Stat. 2156 (25 U.S.C., 1300k et seq.)(hereinafter "Little River Act"); and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, THE Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7(a) of the Constitution, has the power to provide for the general welfare of the Tribe and its members; and
- WHEREAS, the Tribal Council, pursuant to Article IV, Section 7 (i)(2) of the Constitution, has the power to manage any funds within the exclusive control of the Tribe and to appropriate such funds for the benefit of the Tribe and its members; and
- WHEREAS, the Tribal council approved the Fiscal Year 2005 Operating Budget, with adjustments, pursuant to Resolution #04-1215-510; and
- WHEREAS, the Tribal Council approved pursuant to Resolution #04-1222-537 an appropriation for the 1<sup>st</sup> Quarter of Fiscal Year 2005 in the amount of \$6,335,503; and
- WHEREAS, the Tribal Council approved pursuant to Resolution #05-0608-235 and appropriation for the 2<sup>nd</sup> Quarter of Fiscal Year 2005 in the amount of \$7,455,196; and
- WHEREAS, there was no 3<sup>rd</sup> quarter appropriation requested or approved prior to submission of this request; and
- WHEREAS, the Tribal Ogema is requesting that a 3<sup>rd</sup> appropriation of funding for the Fiscal Year 2005 Operating Budget be authorized in the amount of \$4,468,835

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a 4<sup>th</sup> quarter appropriation of funding for the Fiscal Year 2005 Operating Budget for the Tribal Government from the Unrestricted General Revenues in the amount of \$4,468,835.
