

Resolution # 05-1116-604

Authorizing Execution of Engagement Letters with Dan W. Taylor, CPA
To Perform Services as a Consulting Chief Financial Officer

- WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Anišhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Tribal Council has determined it necessary to engage Dan W. Taylor, CPA on a sole source basis to provide continuity in Accounting Department functions of the Tribe; and
- WHEREAS, the Comptroller General has, in consultation with the Tribe's Legal Department, negotiated an engagement letter with Dan W. Taylor, CPA to perform consulting services as a Chief Financial Officer for the Tribe at a rate of \$125.00 per hour for a period of one year;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby authorizes the Ogema to execute the engagement letter within 7 (seven) days of adoption of this resolution retaining Dan W. Taylor, CPA for a period of one year to provide consulting services as the Tribes Chief Financial Officer
