### Resolution # 05-1207-654

*Amending Resolution # 05-1102-563, Approving Supplemental Appropriation for Membership Assistance Program #1000-137 – Tax relief payment of 2005 in the Amount of \$ 1,672,800.00*

WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Aníshinábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Tribal Council wishes to make a one time payment for tax relief to offset any adverse tax effects as a result of Tribal Members receiving the Community Wellbeing and Support payment during 2005; and

WHEREAS, the appropriation of funds from the General Fund will require a modification of the Operating Budget for Fiscal Year 2005, which was approved on December 15, 2004.


WHEREAS, Resolution # 05-1102-563, identified the Account # 5206, which was incorrect and should be changed to Account # 5203.


NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves an amended modification to the Operating Budget for the Tribal Government for Fiscal Year 2005 to include an appropriation of \$ 1,672,800.00 from the General Fund – Gaming Proceeds Account shall be allocated as follows:

Program #1000-137 Membership Assistance Department, **Acct. #5203**, Subaccount 212 – Membership Assistance - \$ 1,672,800.00
