Resolution # 05-1207-657

Approval of a Supplemental Appropriation to the Community Center Program (#2000-452) in the amount of \$432.49

- WHEREAS, the status of the *Gaá Čhíng Ziibi Daáwaa Anišhinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and
- WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and
- WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and
- WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and
- WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and
- WHEREAS, the Property Office has requested a supplemental appropriation to the Community Center Program (#2000-452) for costs associated with the 2005 Winter Tax Bills for the Township of Filer; and
- WHEREAS, the budget for the Community Center Program (#2000-452) currently has \$4,249.16 remaining for costs associated with the 2005 Winter Bills for the Township of Filer, which is \$432.49 less than the total obligation of \$4,681.65; and
- WHEREAS, the Tribal Council has received a request for approval of the above expenditure; and

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves the supplemental appropriation within the Community Center Program (#2000-452), Account #5701 in the amount of \$432.49 for the 2005 Winter Tax Bills for the Township of Filer.
