Resolution # 05-1214-676

Approval of a Supplemental Appropriation to the Newland Building Program (#2000-456) for the 2005 Winter Tax Bills for the Township of Manistee in the amount of \$3,323.09

WHEREAS, the status of the *Gaá Čhing Ziibi Daáwaa Aníshinaábek* (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribe adopted amendments to the Constitution on April 26, 2004, which became effective upon approval by the Assistant Secretary-Indian Affairs on May 13, 2004; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education and general welfare of the Little River Band and its members; and

WHEREAS, the Tribal Ogema is requesting a supplemental appropriation to the Newland Building Program (#2000-456) for costs associated with the 2005 Winter Tax Bills for the Township of Manistee; and

WHEREAS, the available budget for the Newland Building Program (#2000-456) currently has \$1.46 remaining for costs associated with the 2005 Winter Tax Bills for the Township of Manistee, which is \$3,323.09 less than the amount needed to fulfill the total obligation of \$3,324.55; and

WHEREAS, the appropriation of funds from the General Fund will require a modification of the Operating Budget for Fiscal Year 2005, which was approved on December 15, 2004; and


NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby approves a modification to the Operating Budget for the Tribal Government for the Fiscal Year 2005 to include an appropriation of \$ 3,323.09 from the Unrestricted General Revenues for the 2005 Winter Tax Bills for the Township of Manistee. Funds shall be allocated as follows:

Program #2000-456 (Newland Building) Account #5701 – Taxes \$3,323.09

Presentation of Resolution Budget Modification to Tribal Ogema:


