### Resolution #05-1221-715

*Approval to extend the implementation date for the "Lodging & Occupancy Tax", "Food & Beverage Tax", and "Admissions Tax" to February 1, 2006*

WHEREAS, the status of the Gaá Čhíng Ziíbi Daáwaa Aníshinaábek (Little River Band of Ottawa Indians) as a sovereign and Treaty-making power is confirmed in numerous treaties, from agreements with the initial colonial powers on this land, to various treaties with the United States; and

WHEREAS, the Little River Band of Ottawa Indians (Tribe) is descended from, and is the political successor to, the Grand River Ottawa Bands, signatories of the 1836 Treaty of Washington (7 Stat. 491) with the United States, as reaffirmed by federal law in P.L. 103-324, enacted in 1994; and

WHEREAS, the Tribe adopted a new Constitution, pursuant to a vote of the membership on May 27, 1998, which Constitution became effective upon its approval by the Assistant Secretary-Indian Affairs on July 10, 1998; and

WHEREAS, the Tribal Council is authorized under Article IV, Section 7(a) to provide for the public health, peace, morals, education, and general welfare of the Little River Band and its members; and

WHEREAS, the Tax and Revenue Administration Ordinance #05-100-08 was adopted by Tribal Council by Resolution #05-1214-687 for implementation on January 1, 2006;


WHEREAS, the Tribal Council recognizes the importance of maintaining good public relations with customers of the Little River Casino Resort; and


WHEREAS, the Tribal Council understands that extensive promotional advertising for the month of January, 2006 has not included the new taxes levied in Ordinance #05-100-08;

NOW THEREFORE IT IS RESOLVED THAT the Tribal Council of the Little River Band of Ottawa Indians hereby extends the implementation date for the "Lodging & Occupancy Tax", "Food & Beverage Tax", and "Admissions Tax" to February 1, 2006. The "Retail Sales Tax" implementation date shall remain January 1, 2006.
