LITTLE RIVER BAND OF OTTAWA INDIANS TRIBAL COUNCIL MEETING MAY 14, 1995

I. GENERAL BUSINESS

a. Call to Order. Meeting was called to order by Vice-Chairperson Bonnie Kenny at 12:10 p.m. at the office.

b. Roll Call. Tribal Council members present: Anne Avery, Margaret Chandler, Bonnie Kenny, Jerry Guenthardt, Marcella Leusby, Kathy Berentsen. Absent: Bob Guenthardt and Dan Bailey. Guest present: Grand River Band Mason Kent, Bill Brooks, Mark S., By Lyon, Jay Sam, Katie Gloceski. Staff present: Diane Lonn.

c. Adoption of Agenda. Motion was made by Bonnie to accept agenda, Jerry seconded, all in favor, I. Passed.

Adoption of Minutes. Kathy didn't have minutes ready-tabled.

e. Financial Report. Remain of loan be returned to NW Savings. Loan due in July will be paid in full. ANA 1st installment will be drawn down on Wednesday. Loretta used new forms on month base. Little more information, Phone was held because stick. Jerry made motion, Bonnie seconded, passed.

Mark's comment, things do take time to accomplish. He states that we are making great progress, expecially seeing we don't have any money. Katie's concerned about money help besides Casino.
