#### III. DEPARTMENT REPORTS

#### A. Education Department

Y. Parsons reported for the Education Department. Parsons reported the JOM/LRBOI Student Services Program which assists with expenses for children K-12 has assisted 51 students. Also, the JOM activities have included Super Saturdays, helping Natural Resources with sturgeon assessment, and a field trip to Career Expo. The adult education program has assisted 28 Tribal members with \$500 incentive grants and six of the 28 were currently attending college. Since January 2002 twenty-nine Tribal members have received Higher Education Scholarships ranging up to \$2,000. Seventy-six Tribal members have received a college book stipend ranging from \$100 to \$400 determined by number of credits enrolled. Four Tribal members were enrolled in the Vocational Education program which provided work skills. Sixteen Tribal members have received assistance from the Educational Advancement Fund which helps defray costs in testing, licensing, certification etc. Discussion was held regarding the benefit to Tribal members of these various programs. The Council members thanked Parsons for the positive report.

#### **B.** Director of Operations Report

Bob Davis stated in the past two years total number of employees had risen from 60 to 190. Davis indicated he felt phase one of the up-staffing was now complete. Davis suggested the Tribe was now ready to enter into phase two which would be to implement line/staff, policies and procedures to obtain organization of the departments and individual responsibilities. Also, once these things were in place a method to measure accomplishment could be established.

Davis reported the Commodities Program has been getting more exposure in the Muskegon area and as a result more Tribal members in that area were able to be served.

The Tribal newsletter was discussed including topics such as material to include in the newsletter, responsibility of authenticity of articles, proofreading, etc. It was suggested perhaps a PR person should be added to the staff, in fact a mid-year appropriation change to establish a PR position was suggested.

The issue of Indian Preference and the fact the hiring policy had been changed at the Casino were discussed.

Travel issues were discussed such as travel advances, policy for use of vehicles the Tribe was responsible for, submitting of reports after attending conferences, and ascertaining drivers of those vehicles were properly licensed. Davis explained the procedure for obtaining the use of a vehicle. Davis indicated he planned to have a travel policy in place by the end of May.

McCatty questioned employees serving on Commissions during working hours. They receive their wages plus a stipend. Also, how were they being represented as an employee or as a member of that Commission.

McCatty asked when the Planning Department would have the plans in place for the use of the cemetery.
