DNR will hire tribal members to do operation on weir so tribe could take it over for next year. Proceeds from fish/egg allow up to take grere weir. First, contact Jim E. outline what tribes goals are, membership has to have input with operations. DNR will pay for tribes expertise. Dan asked Bill to set up meeting this week with Jim. Council delegate body of people to undertake responsibility. Alternate Dan, Jay, Bob, Connie Alternate, Bill. Marcella made motion, Margaret seconded.
