

LITTLE RIVER BAND OF OTTAWA INDIANS TRIBAL COUNCIL MEETING JULY 24, 1995

I. GENERAL BUSINESS

- a. Call to Order. Meeting was called to order at 6:20 p.m. at the office.
- b. Roll Call. Tribal Council members present: Bonnie Kenny, Marcella Leusby, Margaret Chandler, Kathy Berentsen, Bob Guenthardt, and Annie Avery. Absent: Dan Bailey, excused. Staff present: Mark Dougher, Diane Lonn.
- c. Adoption of Agenda. Motion was made by Bob to accept agenda, supported by Margaret, passed as is.
- d. Staff Report. Diane enrollment she enrolled 87 new members last two weeks. Rap up forest festival. Port City September 9 & 10. Drum team 1-2 on 9th. Arts/Craft and food booth get together.
